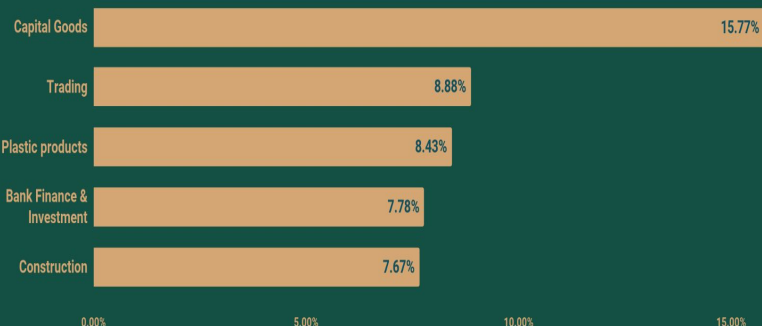
Objective

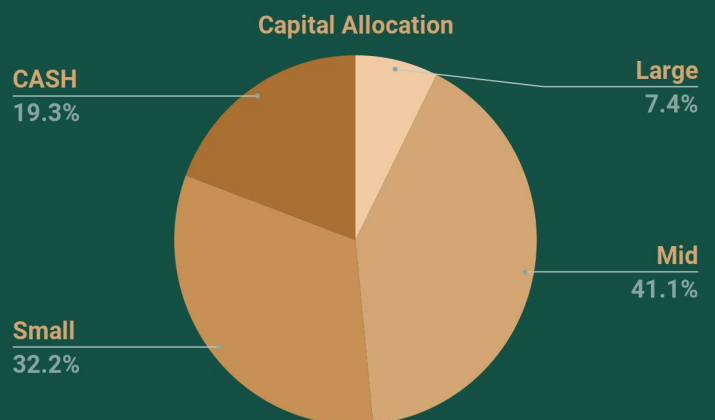

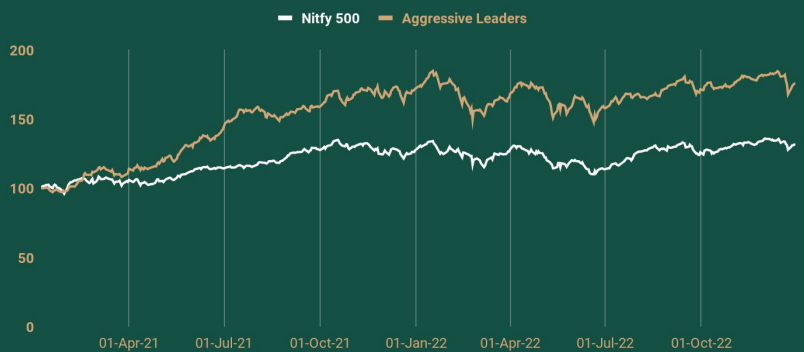
