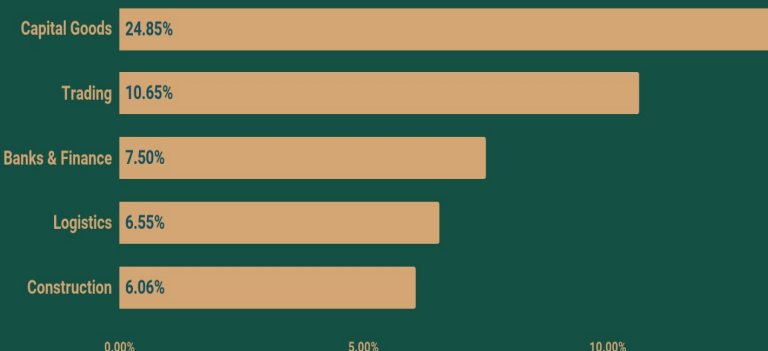
Objective

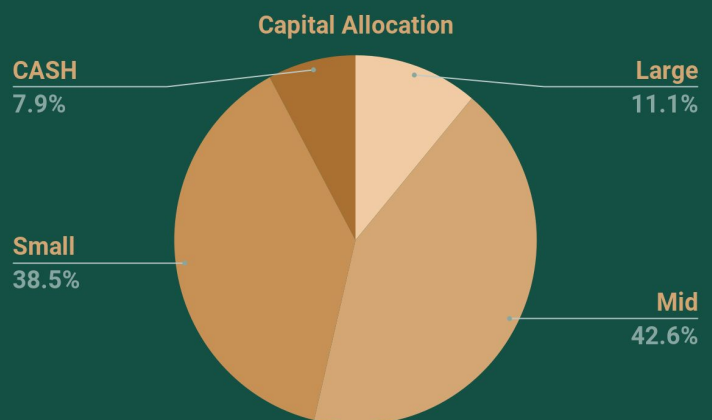

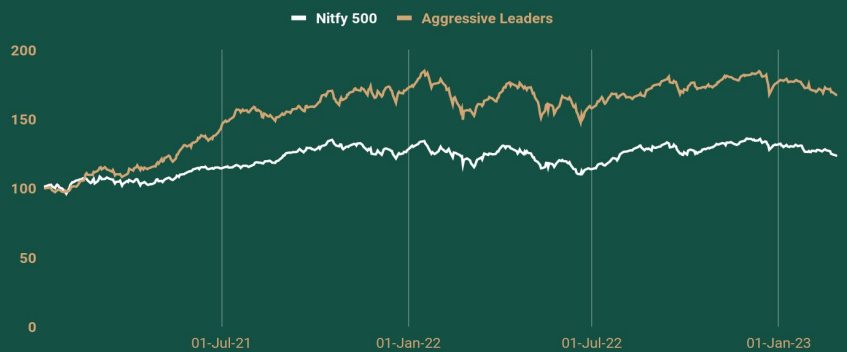
