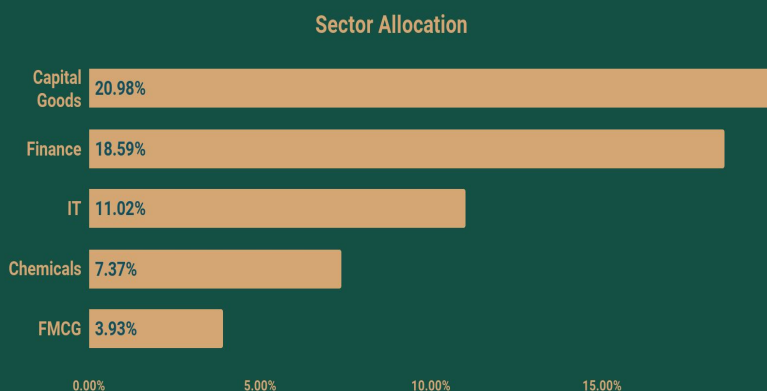
## Objective

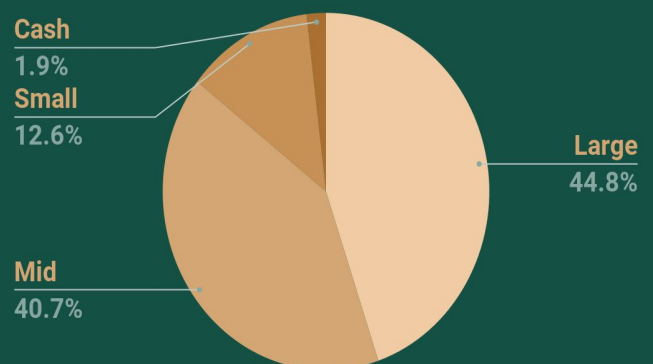

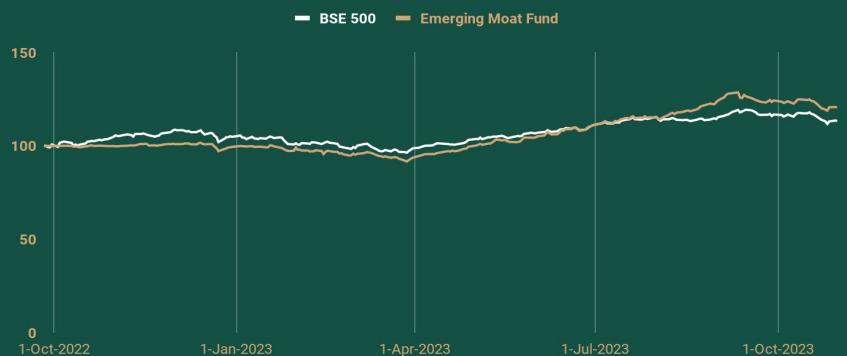
