## Objective

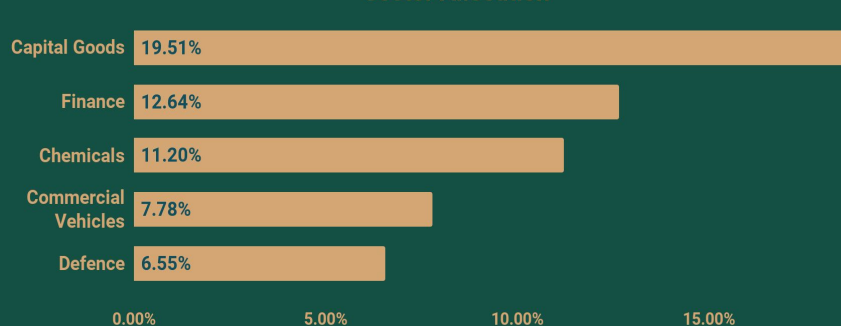

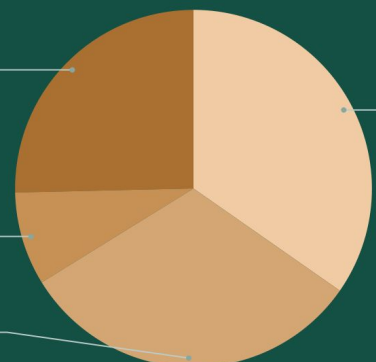

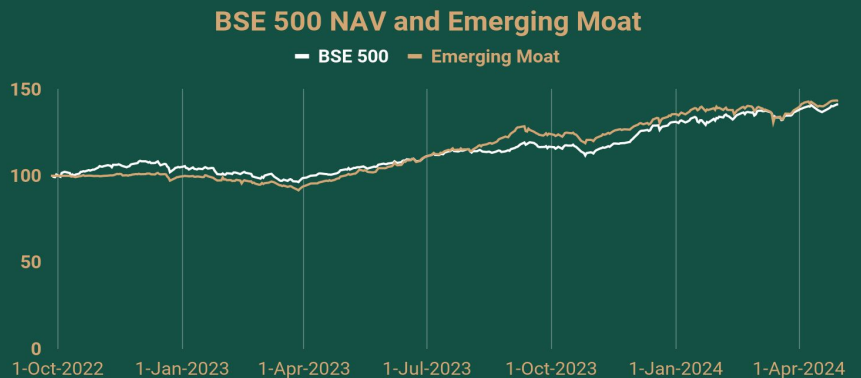
