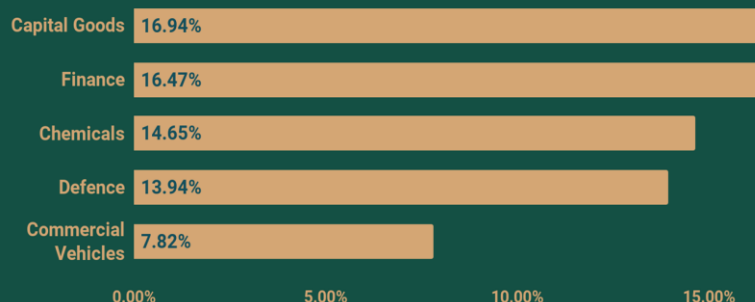
Objective

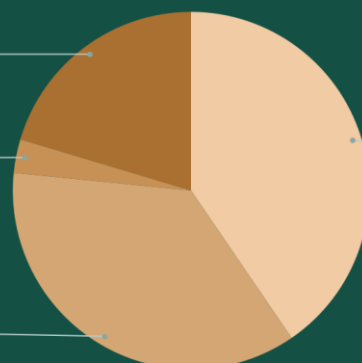

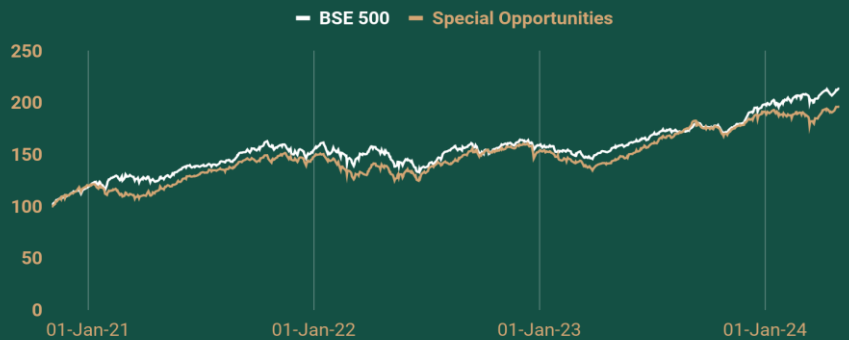
