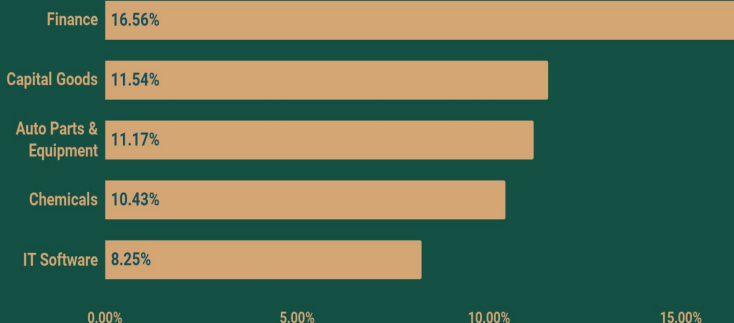
## Objective

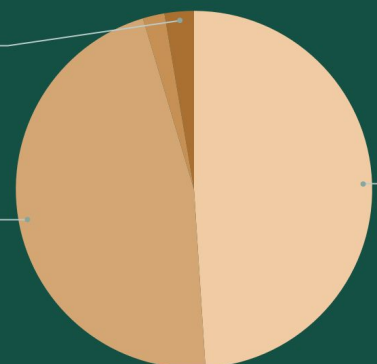

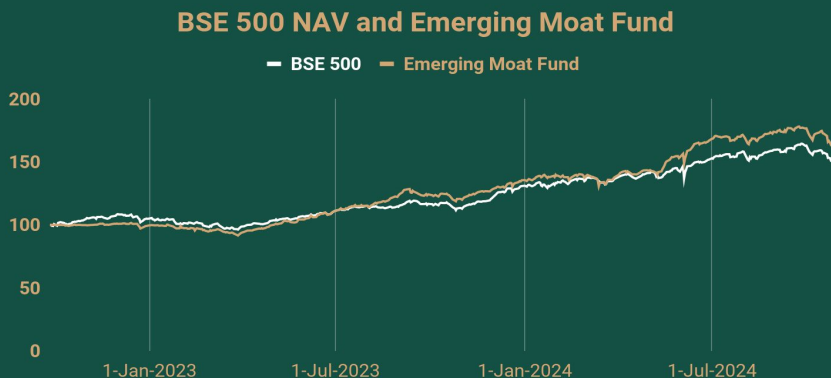
