Objective

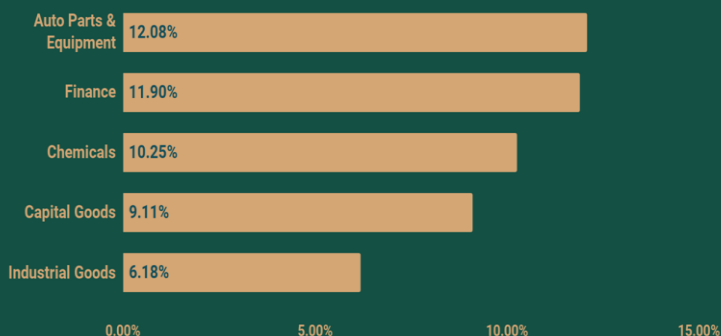

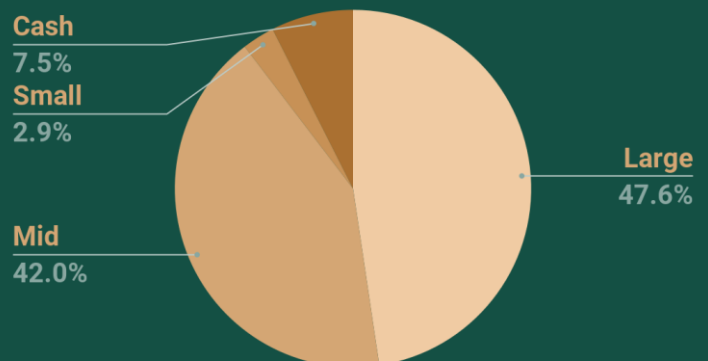

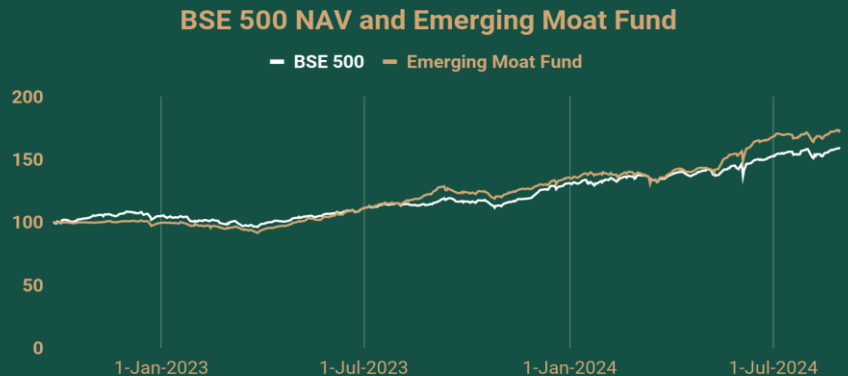
