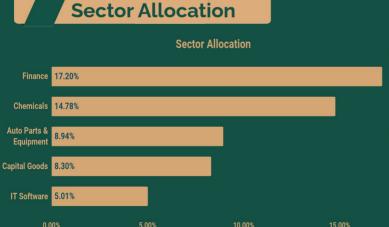


#### **Objective**
