## Objective

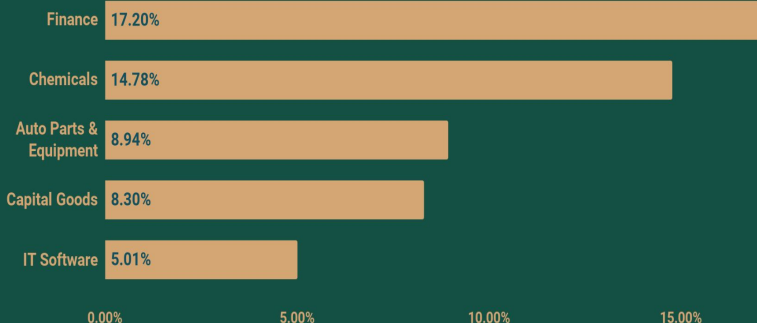

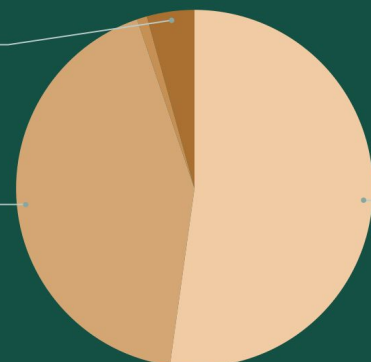

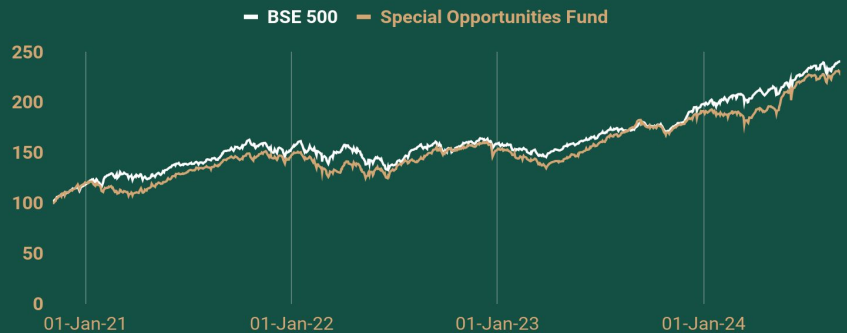
